#### WHAT IS THE BIBLE?

The one sufficient revelation of God is Jesus Christ, the Word of God incarnate, to whom the Holy Spirit bears unique and authoritative witness through the Holy Scriptures, which are received and obeyed as the word of God written. The Scriptures are not a witness among others, but the witness without parallel."

### WHAT KIND OF AUTHORITY?

- Authority is domain specific—to which domain(s) does scripture belong?
- Not primarily a legal/academic text—a different kind of power.
- 2 Timothy 3:16-17—a *teaching* authority.
- Scripture's authority denotes the Bible's capacity to shape and transform people into mature communities of faith. ~William P. Brown
- Formative Authority: auctoritas



### SCRIPTURE AS SCRIPT

- The Myth of Scriptlessness
- Which scripts have shaped us?
  - These dominant/dominating scripts are not neutral
- An Alternative Script(ure)
  - De-scription, disengagement...formation
- The Elusive, Irascible Author of our Script



### SCRIPTURE IN THE CHURCH

- The Bible belongs to the Church—what impact does that have?
- Scripture reading points beyond itself
  - Not a research project
- Scripture reading is a communal practice of faith
  - Repeated over time, done together, rooted in conviction
- Scripture reading is an art
  - · Creative act, aims for beauty, each project is unique
  - How to learn? Apprenticeship

## THE AUTHORITY OF TOUGH TEXTS

- "No biblical text may be safely repudiated as a potential source of edification for the church. When we think we have reached the point of zero edification, then that perception indicates that we are not reading deeply enough." ~Ellen Davis
- Insufficient strategies: outright dismissal and vapid whitewash
- Charitable reading
- Suggested Strategies
  - Difficult texts are worthy of charity from interpreters
  - Wrestling is an act of faithfulness
  - Seek the blessing...enlarge the field of view (key themes)
  - · Learn from dangers as well as insights in the text

Charitable reading requires considerable effort. It is easier to dispense with the difficult text. Those who regard a text as religiously authoritative are willing to sustain that effort, because they perceive it in some sense as a gift from God. ~Ellen Davis

"We read neither with a kind of blind and thoughtless obedience to every word of scripture, as if it simply represented the mind of God, nor do we read with that rather priggish sensibility that desires to look down on the authors of scripture as benighted savages. We read with a sense of our own benighted savagery in receiving God's gift, and our solidarity with those writers of scripture caught up in the blazing fire of God's gift who yet struggle with it, misapprehend it, and misread it"
